1. Definitions

- (a) "Software", the object code of the computer program known as *Galaxy Examiner – the STDF detective* that includes any modifications carried out by us or on our behalf.
- (b) "Intellectual Property Rights" or "IPR", all intellectual property rights including, without limitation, patents, trade marks, design rights, copyright, database rights, moral rights (whether or not any of these is registered and including any applications for registration of any such rights), know-how, confidential information and trade secrets and all rights or forms of protection of a similar nature or having similar effect to any of these which may exist or come into existence in the future anywhere in the world.
- (c) "License", the license to use the Software under this Agreement.
- (d) "Licensor", Bealach na BóFinne Teo T/A GALAXY
- (e) "Registered User", user of the Software that has completed the registration process and provided accurate information. The registration process can be either done on-line from our web based registration form at the time of the Software download, or by email when requesting the Software from sales@galaxysemi.com.
- (f) "Freeware", the Software can be used at no cost provided the License respects the License terms
- (g) "Expiration date", the date after which the Galaxy Examiner Freeware release will stop working.

2. License Terms

"We", "us" and "our" refer to GALAXY. "You" and "your" refers to the individual that proposes to install and/or use the Software.

3. What This License Agreement Covers

- (a) As a Registered User, you are granted a non-exclusive license to use the Software on a single computer free of charge for non-commercial use subject to the terms and conditions of this Agreement.
- (b) The Freeware will stop functioning after it reaches the Expiration date. Licensor may decide at any time and without notice to discontinue the Freeware availability.
